National Commitee participation in monitoring CRC – Convention on the Rights of the Child:

- Documenting efforts to raise awareness of early childhood care and education as a right
- Participation in the project OMEP CREATIVE ART WORLD OMEP Draw Your Rights - 4 children from Hlohovec
- Respect for the rights of the child in kindergartens is incorporated into all important documents, it is also part of the State educational program for pre-primary education in kindergartens, school regulations, work plans, school educational programs, some kindergartens have their own projects ...

Education for sustainable development in early childhood:

- the OMEP ESD rating scale as an environmental assessment scale in early childhood - the intention is to develop this tool as a research tool as well as a self-assessment tool for practitioners
- OMEP is involved in education for sustainable development it has been implementing in conferences on sustainable development for several years, outdoor activities - in project "Take me out"

Special national dates celebrated in 2020:

- Collection of activities for kindergartens in the publication "Inspirations for the Day of Kindergarten 2020"
- Possibility to publish in a peer-reviewed proceedings with international participation on the Day of Kindergartens in Slovakia under the title "Educational Reality in Kindergartens"

- Art show on the occasion of the Day of Kindergarten in Slovakia 2020

Participation in Global Projects:

- WASH from the start
- Colour your rights:

Article 8: To respect the right of the child to preserve his / her own identity, Including nationality, name and family relationships, as recognized by law, and not to allow unlawful interference.

Article 18: Recognition of the principle that both parents share responsibility for the upbringing and development of the child. Parents or guardians have primary responsibility for the upbringing and development of the child. The best interests of the child will be their primary concern.

Article 28: Right of the child to education in order to achieve this right gradually and on an equal opportunity basis.

Article 31: Right of the child to rest and leisure, the right to engage in play and recreational activities appropriate to his or her age, and to participate freely in cultural life and the arts.
